TRACK SURFACE: Can be asphalt, concrete or plywood construction (over grass). The event cannot run

directly on grass. The surface must be smooth and level (no dips or potholes). Fast Track Entertainment, Inc. can provide a plywood track for an additional fee of \$350.00.

SHOW AREA: The competition requires an area at least 24' W x 50' L for trailer, fencing, and equipment.

SEATING: Low level bleachers are preferred. Straw bales in addition to bleachers work well also. We know shaded areas are at a premium but are appreciated by any audience on a hot summer day. **A covered seating area is ideal!**

ELECTRICAL: A dedicated 15 amp. (120 volt) outlet must be available and located not farther than ten feet from staging area.

SOUND EQUIPMENT: We provide all the necessary audio components required for our show. Yes, it can get a little loud at times! The Kids Pedal Tractor Pull Competition is a production and may interfere with vendors if they are placed too close to the staging area. On the other hand, some vendors love it because it's good for business!

SHOW TIMES: The show lasts approximately 25-30 minutes. It is necessary to have 10 minutes before each show for kids to sign up. The best show times have proven to be in the $\frac{\text{middle to late afternoon}}{\text{minutes before sunset (approx. 1:00 pm} - 7:30 pm)}$.

PRIZES: Giving prizes away for participation is always a bonus. In the past, fairs have provided us with a variety of items such as ribbons, shirts, coupons (free ice cream from McDonalds etc.) to hand out to all the kids in the show. Prizes are not a required component but are always fun to have if available. We award each participant with a special "Kids Pedal Tractor Pull" ribbon.

OTHER REVENUE: Fast Track Entertainment reserves the right to sell tee shirts and/or photos after each show and retain all revenues.

LODGING: The Fair is to provide all lodging for our staff. Unless otherwise requested, we require one non-smoking room with **two beds**. Date of check-in is to be at least one day prior to opening day of the fair. Date of departure is to be the day following the last day of the fair (if the fair ends on a Sunday, check-out is Monday morning).

ATTACHMENT B Fast Track Entertainment, Inc. Contract Kids Pedal Tractor Pulls

- 7. a. The ATTRACTION shall maintain Primary Commercial General Liability Insurance with a limit of not less than \$1,000,000 per occurrence and name Weber County Corporation as an additional insured. ATTRACTION shall provide the Fair with a certificate of insurance, verifying coverage at least one week prior to the event.
- b. The ATTRACTION further agrees to assume all liability for any claim arising out of any accident or damage to its property and to the person and property of the participants and hereby releases Weber County, its officers, agents, and employees from every claim, liability, or demand of any kind sustained by Contractor's participants, licensees, agents, and employees.
- c. ATTRACTION shall defend, indemnify and hold Weber County, its agents and employees harmless from and against all claims, liabilities, loss and expense, including reasonable costs expenses and attorney's fees incurred, which arise by reason of the acts or omissions of the ATTRACTION, its officers, agents and employees, resulting directly or indirectly from the performance of this Agreement by ATTRACTION unless said loss, liability or claim is caused solely by Weber County's negligence.
