JOB SUMMARY Under general supervision of the County Attorney, performs investigative duties for the County Attorney's Office and for other outside agencies when requested and approved by the County Attorney. MAJOR DUTIES (Any one position may not include all of the duties listed, nor do the listed examples include all duties which may be required in positions of the class.) Investigates crime and prepares reports for prosecution of criminal cases. Arrests persons committing offenses. Investigates charges of misconduct on the part of public agencies or their employees. Investigates corporate fraud, white collar crimes, organized crimes, and other crimes of an economic nature. Testifies in court as necessary. Investigates and prepares reports related to personnel, civil investigations, and internal investigations as directed by the County Attorney. Investigates officer involved shootings and participate in the homicide task force. Performs related duties as assigned.

<u>MINIMUM QUALIFICATIONS</u> Graduation from college or university with a bachelor's degree in business management, political science or a related field AND/OR Five years of investigative experience demonstrating increasing responsibility and understanding of legal and/or administrative work.

Considerable knowledge of modern office practices and procedures; working knowledge of modern law enforcement principles, procedures, and techniques; working knowledge of court procedures and rules of evidence. Skill at using tools and equipment listed. Ability to communicate effectively, verbally and in writing; ability to establish and maintain effective working relationships with other departments and the public in general.

<u>SPECIAL QUALIFICATIONS</u> <u>Must be certified as a Category I Police Officer in the State of Utah</u>; Must be 21 years of age or older at the time of employment; Must possess, or be able to obtain by time of hire, a valid Utah Drivers License without record of suspension or revocation in any State; Must not have any felony convictions and disqualifying criminal histories within the past seven years; Must be a U.S. Citizen, and be able to read and write the English language; Must be of good moral character and of temperate and industrious habits.

<u>TOOLS AND EQUIPMENT USED</u> Personal compute, typewriter, camera, tape recorder, police car, police radio, handgun and other weapons as required, side handle baton, handcuffs, pager, cell phone, first aid equipment, etc.

PHYSICAL DEMANDS The physical demands described here are representative of those that must be met by an employee to successfully perform the essential functions of this job.
