<u>JOB SUMMARY</u> Under general supervision of Department Director and under direct supervision of the Director of Health Promotion, designs and conducts community health education programs. Is responsible for the development and implementation of preventionoriented public health education programs which may include tobacco prevention education, and cessation, intentional and unintentional injury prevention, lifestyle management, chronic disease prevention and teen pregnancy prevention. <u>MAJOR DUTIES</u> (Any one position may not include all of the duties listed, nor do the listed examples include all duties which may be found in positions of this class.) Will perform the following specific functions:

<u>PREVENTION EDUCATION</u>: Develop and present effective health education programs, including lesson plans, presentations and community outreach. Programs may include smoking and smokeless tobacco use, nutrition, physical activity, self esteem, injury prevention, lifestyle management and other community and personal health issues.

<u>COMMUNITY ASSESSMENTS</u>: Plan and implement surveys or other methodology to evaluate community health education programs and activities.

<u>CONTRACT MANAGEMENT</u>: Negotiates annual contracts with state and other agencies for health education services. Prepares reports and performs other contract activities as negotiated in annual contracts.

<u>POLICY DEVELOPMENT AND ENVIRONMENTAL CHANGE</u>: Works with policy makers in the community to develop policies and promote changes in the environment to encourage healthy behavior.

<u>OTHER PUBLIC HEALTH PROGRAMS</u>: Assist the Divisions of Public Health Nursing, Environmental Health and Women Infant and Children with the development and implementation of effective public health education programs.

Identifies and evaluates health education needs in cooperation with community groups; assists in establishing objectives and planning the educational programs to address health problems; utilizes community organizations and involves local leaders in desired community action to achieve the educational objectives. Assists staff of related health programs in assessing health education needs and planning solutions.

Provides consultation regarding evaluation techniques to measure success of educational programs; utilizes the mass media effectively as part of the educational process; establishes and maintains working relationships with schools, hospitals, physicians, public officials, community groups and voluntary agencies which have interest in specific studies.

<u>MINIMUM QUALIFICATIONS</u> Graduation from a college or university with a Bachelor's Degree in Public Health Education, Community Health Education, Public Health, Lifestyle Management or a closely related field, AND One year of experience in community health education, OR A Master's Degree in Health Education, Public Health, Public Administration or a closely related field. *Experience in a clinical environment a plus*.

Considerable knowledge of the psychological and physiological effects of tobacco, alcohol and illicit drugs; Considerable knowledge and understanding of pubic health methods and procedures; Considerable knowledge of health education methods and preventative health practices; Considerable knowledge and understanding of behavior modification principles and methods; considerable knowledge of community analysis and survey techniques, needs assessment, and principles of community development and organization; considerable knowledge of educational tools and use of the media for information dissemination; considerable knowledge of state and local political processes; considerable knowledge of materials, aids, literature, and services available in the field of community health.

Skills in delivering presentations to individuals and groups; considerable skill in communicating verbally and in writing; basic computer and word processing skills.

Ability to develop curriculum, lesson plans, skill building activities, audio-visual materials and other motivational and educational materials; Ability to assess community and personal health needs and plan and implement effective pubic health programs; ability to work with antagonistic or even hostile people; ability to communicate effectively and professionally verbally and in writing; ability to adapt presentations and materials to meet the needs of culturally diverse populations; ability to establish good working relationships with federal, state and local agencies, employers, property owners, hospitals, health care providers, human service providers, and other local health departments, Utah Department of Health, local school districts, business and civic leaders, elected officials and the general public.
