Responds to telephone and radio requests for emergency mechanical repair of department equipment in the field. Perform Inspection/Maintenance (IM) and State Safety inspections. Delivers various lubricants and fuels to equipment in the field. Assists with Fleet Management program as directed. Assists other County personnel in their vehicle needs when instructed to do so by the Shop Superintendent. Inspects, checks, maintains, services, cleans, and ensures that the Motor Pool is ready for daily operation under the direction of the Shop Superintendent. Performs other work as assigned.

<u>MINIMUM QUALIFICATIONS</u> High School graduation or equivalent, AND One year of experience in the repair and maintenance of automotive and heavier equipment. OR Any equivalent combination of education and experience.
