JOB SUMMARY Under the close supervision of a Heavy Equipment Crew Leader, performs a variety of semi-skilled and skilled work in the operation of light equipment, machinery, and tools used in construction, maintenance, repair, and snow removal activities. <u>MAJOR DUTIES</u> (Any one position may not include all of the duties listed, nor do the listed examples include all duties which may be found in positions of this class.) Operates single axle dump trucks (up to 25 tons), power brooms, forklifts, and jackhammer in construction, maintenance, repair, and snow removal operations. Checks and services assigned equipment; performs routing maintenance and emergency repairs; reports mechanical problems for shop repairs. Operates heavier equipment on a limited training basis as assigned. Operates a variety of mowing equipment in the maintenance of county roads and other facilities. Skill in the operation of assigned equipment. Ability to operate assigned equipment under varying conditions; ability to perform minor equipment maintenance and repair; ability to learn and follow standard safety practices and procedures common to equipment operation work; ability to follow written and verbal instructions; ability to establish and maintain effective working relationships with employees and the general public.
