1. **SUBDIVISION OF COUNTY PROPERTY, INCLUDING PARTS OF PARCELS 12-101-0010, 12-098-0021, 12-098-0043, 12-098-0042, 12-098-0048, 12-098-0046, 12-098-0047, 12-098-0049, INTO THE DETENTION CENTER SUBDIVISION**

Devron Andersen, of the County Recorder/Surveyor's Office, stated that these properties are near the County Sheriff's complex and the county is combining the multiple disjointed parcels into two buildable lots. Ogden City reviewed and approved this action.

2. **CONTRACT WITH UTAH COUNTY PUBLIC DEFENDERS ASSOCIATION TO PROVIDE APPELLATE COUNSEL FOR THE WILLIAM TIRADO CASE – CONTRACT C2015-301**
3. **CONTRACT WITH EMILY ADAMS TO APPEAR ON BEHALF OF AND REPRESENT COURTNEY'S APPELLATE INTERESTS IN 20141171-CA AND 20141172-CA – CONTRACT C2015-302**

David Wilson, Deputy County Attorney, addressed items F.2 and F.3 together. He noted that Samuel Newton has the appellate contract with the county to handle all appeals related to indigent defense. In the Tirado case, the court determined that there was a conflict of interest for Mr. Newton. These indigent defendants are accusing each other. The Utah County Public Defenders are representing the Tirado case and asked if possible that Weber County buy them a computer and computer equipment in lieu of paying them directly. It has not been determined if this is possible; if it is not, Weber County will pay them \$5,000.

The Courtney item has two separate cases (for a total of \$10,000)

Commissioner Ebert moved to approve Contract C2015-301 with Utah County Public Defenders Association to provide appellate counsel for the William Tirado case and Contract C2015-302 with Emily Adams to appear on behalf of and represent Courtney's appellate interests in 20141171-CA and 20141172-CA; Commissioner Bell seconded.
