

Weber County Fair

Soccer Tournament

August 8 – 11, 2007

We are pleased to extend your Team/organization an invitation to participate in the Annual **Weber County Fair Soccer Tournament**. The purpose of the tournament is twofold: 1) provides soccer players the opportunity to foster and exhibit **SPORTSMANSHIP** in a competitive environment and 2) promote physical development.

The tournament has been scheduled for August 8 – 11, 2007.

The venue for the tournament is the Weber County Fair Grounds located at 1100 North 1200 West Ogden, Utah. The event is held in conjunction with the **Weber County Fair**.

ELIGIBILITY: The Weber County Fair Tournament is open to any team. Players need only to hold a player ID card. This invitation is for girls, boys and co-ed teams (co-ed teams other than U19 competes in the boy's league). For U16/U19, play will be for co-ed teams only. All U16/U19 teams must have at least a minimum of 5 female registered players, 3 of which must be on the field at all times.

Players cannot play on more than one team in the tournament. NO Exceptions!

Check-In: Coaches are expected to check-in their team at Tournament Headquarters at the Golden Spike Fair Ground thirty (30) minutes prior to the teams' first game. The roster will be finalized at the time of check-in and substitutions will not be allowed thereafter. The tournament officials will make exceptions for catastrophic injury only. Each coach will be required to have in his/her possession:

- 1) Tournament roster with waiver signatures by guardians,
- 2) A coaches card with picture,
- 3) Player identification cards with pictures,
- 4) A copy of each players birth certificate,
- 5) A first aid kit.

Rules: Each team will play a minimum of four (4) games. Total points for the first three games are used to determine playoff bracket. This method places the more experienced teams in their own bracket allowing the less experienced teams the opportunity to also compete for awards single elimination playoff follows for each bracket after the initial games. This is the only tournament in Northern Utah to use this format.

REGISTRATION: Tournament registration fee per team is listed above. A refundable \$175.00 referee deposit is also required at the time of registration. Please make two checks payable to "Weber County Tournament". Team registration form and roster, referee registration form, and fees must be received by July 10, 2007. A full refund will be issued after July 10, 2007 only to those teams that can be replaced with another team.

Maps tournament rules, games schedules, and referee schedules will be sent to each team's coach one (1) week prior to the tournament. The required entry forms are attached.

Incorrect or incomplete forms will be returned for correction with no guarantee of an open slot for your team.

REFEREE OBLIGATION: The Weber County Tournament runs a full tree-man referee system. Your team will be given center referee assignments and assistant referee assignments. When you are assigned to provide a center referee, you must provide a fully trained, competent center referee. Referees must hold appropriate certification. Referees must dress in full uniform. Youth referees can referee teams at least 2 years younger than they are. Each team will be assigned to referee one game for each game played including play-offs. Failure to provide a competent referee will result in a partial or complete loss of the referee deposit depending upon number of games refereed. The referee deposit check will be returned to the “payee” at the completion of the refereeing assignments. Teams who participate in play-offs will be required to provide referees and/or assistant referees for additional games. **If your team is unable to provide a qualified referee, please so state on your Referee Roster. Note: if you do not provide referee information on your Referee Roster or you do not return your Referee Roster with your Team Roster, we will assume you will not be providing referees and will deposit your check.**

TROPHIES/AWARDS: Each player and coach will receive a Weber County Golden Spike Fair Tournament T-shirt. Players on the first and second place teams of each bracket will receive individual trophies. The tournament will provide awards to each winning team based on the “suggested roster size” plus an award for the coach.

TOURNAMENT: The tournament will be limited to 80 teams on a first-come-first-served basis. The Tournament Committee reserves the right to combine age groups within a division as necessary. Also, there must have a minimum of four (4) teams for each division and/or flight in order to play that division/flight. If the number of teams is not reached, we will inform you as soon as possible of the cancellation of that division and refund your registration and referee fees in full.

ACTIVITY: The Weber County Fair will provide normal fair activities during the entire tournament.

We look forward to your participation in the **Weber County Fair Soccer Tournament.**
