5. **FRST READING OF AN ORDINANCE GRANTING AN ELECTRIC UTILITY FRANCHISE AND GENERAL UTILITY EASEMENT TO ROCKY MOUNTAIN POWER**

Steve Rush, of Rocky Mountain Power, stated that as a regulated public utility, Rocky Mountain Power, provides electric power/energy to Weber County citizens and surrounding areas. Electric power requires installation, operation and maintenance of power poles, etc., to be located within public ways of the county. The term of the franchise is for 10 years from date of acceptance by the county. This does not preclude the county from carrying out its activities within these public ways.

Commissioner Zogmaister moved to approve the first reading of the Ordinance Granting an Electric Utility Franchise and General Utility Easement to Rocky Mountain Power; Commissioner Gibson seconded, all voting aye.
