Commissioner Zogmaister moved to approve the consent items; Chair Dearden seconded, both voting aye.

E. ACTION ITEMS:

1. **ANNEXING THE WEBER COUNTY HAZARDOUS WEATHER PLAN INTO THE EMERGENCY OPERATIONS PLAN ADDRESSING WEATHER EMERGENCIES**

Eli Johnson, of County Emergency Management, stated that for the past two years Emergency Management, has been writing and preparing for a storm-ready plan in conjunction with the National Weather Service (NWS) Storm-ready program to assist local government agencies in receiving, analyzing and disseminating information on hazardous weather within their jurisdictions. This plan was reviewed by the NWS and there was an on-site inspection to ensure compliance. By adopting/participating in this plan, county residents receive an additional 25 community rating system credits towards potential discounts for flood insurance.

Commissioner Zogmaister moved to annex the Weber County Hazardous Weather Plan into the County Emergency Operations Plan addressing weather emergencies; Chair Dearden seconded, both voting aye.

2. FINAL APPROVAL OF THE COLYN FLINDER’S SUBDIVISION (1 LOT), AND REQUEST FOR A DEFERRAL OF CURB, GUTTER AND SIDEWALK

Ben Hatfield, of the County Planning Division, stated that the applicant is requesting to create a 1-lot subdivision for the home built in 1972. Due to prior land divisions, the lot does not conform to the Subdivision and Zoning ordinances, lacking the required width and area for A-1 and A-2 Zones. By subdividing this lot and adding more and property, it will conform to county ordinances. Mr. Hatfield said that the County Engineering Division agrees that there is no need to install curb, gutter and sidewalk. This lot has frontage on a private substandard road and the property owner will sign a substandard road agreement. Road improvements will need to occur when any future building lots are put in.

Commissioner Zogmaister moved to grant final approval of the Colyn Flinder’s Subdivision with deferral of curb, gutter and sidewalk; Chair Dearden seconded, both voting aye.
