**D. PRESENTATION TO SERGEANT NATE HUTCHINSON IN APPRECIATION OF DEDICATED SERVICE ABOVE AND BEYOND THE CALL OF DUTY**

Commissioner Gibson referred to the terrible event that occurred on January 4, 2012, where several Weber Morgan Narcotics Strike Force officers were shot--one fatally—as they served a warrant. He referred to the amazing acts of heroism and selfless service by those officers, and the Commission recognizes Sergeant Hutchinson today for his inspiring acts exhibited that day in protecting/serving our community. The commissioners expressed admiration and gratitude for the way these officers perform their duties to preserve our freedoms. Sergeant Hutchinson was presented with a mounted jersey that a hockey team player wore with his name during a fundraiser. Sergeant Hutchinson expressed thanks for the recognition, stating that he does not do more than what others do. He said that community support has been amazing.

**1. CONTRACT WITH DR. ROBERT W. GROW FOR PHYSICIAN ADVISORY SERVICES - CONTRACT C2012-59**

Brad Dee, County Human Resources Director, stated that Weber County co-owns the license with the Ogden City Fire Department and Roy City Fire and Rescue to provide paramedic services for the county in certain locations. The county is required to have an emergency medical service physician advisor. A Request for Proposals was issued and the interview committee selected Dr. Robert W. Grow. The county agrees to pay Dr. Grow \$30,000/year for the services.

Commissioner Zogmaister moved to approve Contract C2012-59 with Dr. Robert W. Grow for Physician Advisory Services; Commissioner Gibson seconded, all voting aye.

**2. CONTRACT WITH JASON HEWLETT ENTERTAINMENT FOR LOKALGROWN TO PERFORM AT THE 2012 WEBER COUNTY FAIR - CONTRACT C2012-60**

Jan Wilson, of the Weber County Fair, stated that this band will perform on 8/8/12 for \$3,500. She noted that in four months the Weber County Fair is going to celebrate its 25 years.

Commissioner Gibson moved to approve Contract C2012-60 with Jason Hewlett Entertainment for Lokalgrown to perform at the 2012 Weber County Fair; Commissioner Zogmaister seconded, all voting aye.
