### F. ACTION ITEMS:

## 1. ACTION ON A PRESENTATION OF THE QUARTERLY INTERIM FINANCIAL REPORT

Scott Parke, County Comptroller, presented the interim financial report as of March 31, 2015. He noted that expenditures and revenues are where expected. The county budgeted for 4% sales taxes but they may come in closer to 5%. He explained that \$18 million for the corridor preservation funds were turned over by the State to the county to manage. He highlighted the new computer financial system noting that the current accounting system is outdated. The new system will greatly streamline the county's processes.

Commissioner Bell moved to approve this quarterly financial report; Commissioner Ebert seconded.

### 2. APPROVE THE 2015 TAX RATES

Ricky Hatch, County Clerk/Auditor, noted that Utah is a revenue neutral state and explained the State's property tax system, how tax rates are set and truth in taxation requirements. For this year the county received the recommended tax rates from the State Tax Commission and the county has no intention to increase those tax rates.

# 3. RESOLUTION APPOINTING MEMBERS TO THE OGDEN VALLEY PLANNING COMMISSION – RESOLUTION 29-2015

Sean Wilkinson, County Planning Division Director, noted that the Planning Division advertised for three vacancies on this Commission. Two terms expire this month and one other member, whose term expires next June is resigning early. Nine new applications were received and one for reappointment. These are 4-year terms expiring 6/30/2019. The commissioners noted what a difficult decision this was, that these were extremely qualified applicants. They expressed thanks to all those who serve.

Commissioner Ebert moved to adopt Resolution 29-2015 appointing A Stephen Waldrip to serve 1-year, Jami Denise Taylor to serve a 4-year term and the reappointment of Will Haymond to a 4-year term to the Ogden Valley Planning Commission; Commissioner Bell seconded.

New expenditures include some equipment for the Sheriff's Office, \$6,000 for a copier for the Purchasing Division recently split from the Clerk/Auditor's Office, and \$3,000 is being used to help fund some overtime for the Building Inspector's backlog.
