2. **CONTRACT WITH LOS REYES DE LAS PISTAS FOR HORSE RACING MATCHES AT THE GOLDEN SPIKE EVENT CENTER (GSEC) ON 6/26, 7/17, AND 8/21, 2011 - CONTRACT C2011-133**

Jim Harvey, of the GSEC, presented this standard contract.

Commissioner Gibson moved to approve Contract C2011-133 with Los Reyes De Las Pistas for horse racing matches at the GSEC on 6/26, 7/17, and 8/21, 2011; Commissioner Dearden seconded, all voting aye.

3. **CONTRACT WITH OGDEN PUBLISHING CORP. FOR THE STANDARD EXAMINER FALL HOME SHOW AT THE GOLDEN SPIKE EVENT CENTER (GSEC) ON 10/21-22, 2011 - CONTRACT C2011-134**

Jim Harvey, of the GSEC, presented this standard contract.

Commissioner Dearden moved to approve Contract C2011-134 with Ogden Publishing Corp. for the Standard Examiner Fall Home Show at the Golden Spike Event Center on 10/21-22, 2011; Commissioner Gibson seconded, all voting aye.

**4. INTERGOVERNMENTAL AGREEMENT TO PROVIDE FOR INCARCERATION OF UTAH DEPARTMENT OF CORRECTIONS OFFENDERS IN THE WEBER COUNTY JAIL - CONTRACT C2011-135**

Weber County Sheriff Terry Thompson presented this annual contract stating that the county contracts at the State's core rate of \$45/day.

Commissioner Gibson moved to approve Contract C2011-135, Intergovernmental Agreement to provide for the incarceration of Utah Department of Corrections offenders in the Weber County Jail; Commissioner Dearden seconded, all voting aye.

**5. COOPERATIVE AGREEMENT WITH UNITED STATES DEPARTMENT OF AGRICULTURE NATURAL RESOURCES CONSERVATION SERVICES (NRCS) - CONTRACTS C2011-136A & 136B**

Lance Peterson, of County Emergency Management, noted that a contract was approved last week. Because there have been some difficulties with the Hansen property relating to this item, the NRCS asked that the Assurances Relating to Real Property Acquisition form be separated into two contracts to ensure that all the easements are in place. If a mutual agreement cannot be reached with the Hansens, the other projects will not be affected. Mr. Peterson addressed the commissioners' questions regarding how this may affect the funding and the project stating that it did not affect the funding and NRCS is aware that the county is pursuing the entire project.

Commissioner Gibson moved to approve Contracts C2011-136A and 136B with the United States Department of Agriculture Natural Resources Conservation Services; Commissioner Dearden seconded, all voting aye.
