- 1. **CONTRACT WITH U.S. FOREST SERVICE TO PROVIDE LAW ENFORCEMENT/PATROL SERVICES ON U.S. FOREST SERVICE ROADS, CAMPGROUNDS, & OTHER UINTA-WASATCH-CACHE NATIONAL FOREST RECREATION AREAS (2013 ANNUAL OPERATING/FINANCIAL PLANS) - CONTRACT C2012-191**

Reed Richards, Deputy County Attorney, presented this annual contract for \$60,413, the same amount as in past years. This year the Sheriff's Office offered training to Forest Service officers, which helps them understand how to enforce State laws, and a number of Forest Service officers were deputized to enforce State laws. Sheriff Terry Thompson stated that this is a great partnership.

Commissioner Gibson moved to approve Contract C2012-191 with the U.S. Forest Service to provide law enforcement/patrol services on U.S. Forest Service roads, campgrounds, and other Uinta-Wasatch-Cache National Forest recreation areas; Commissioner Zogmaister seconded, all voting aye.
