JB 01/02.00 MISSIONS AND GOALS

JB 01/02.01 **Policy**

It is the policy of the WCCF that:

- A. there is a clear, understandable mission statement which guides the administration, management, and operation of the WCCF;
- B. members shall understand the mission statement of the WCCF, and that their actions and conduct are consistent with the mission and goals; and
- C. the WCCF mission statement will result in a uniform approach to conducting the WCCF business by members.

JB 01/02.02 Rationale

The mission statement exists to set forth the WCCF's:

- A. purpose, direction, and philosophy; and
- B. responsibility to/for offenders under its jurisdiction, the public, and others.

JB 01/02.03 Mission Statement

- A. The Primary Mission of the WCCF is Community Protection.
- B. Community Protection shall be accomplished by:
 - 1. incarcerating offenders consistent with court orders;
 - 2. holding prisoners consistent with statutory responsibility;
 - 3. operating in a manner which significantly reduces the risk of:
 - a. escape;
 - b. offender/prisoner disturbance;
 - c. offender/prisoner on staff violence; and
 - d. offender/prisoner on offender/prisoner violence;
 - 4. generally enhancing safety and security in the system.

- C. The mission of the WCCF may be supplemented by the opportunity to provide limited correctional programming which may become available through various correctional and non-correctional means, including:
 - 1. Community education programs;
 - 2. Treatment programs; and
 - 3. other programs designed to facilitate a more successful re-entry to the community.
- D. To ensure that the operation and management of the WCCF is consistent with its mission and goals, and that the members of the WCCF perform in a professional manner, staff development shall be a priority stressing:
 - 1. operation according to a formalized policy and procedure system;
 - 2. job-related training;
 - 3. staff supervision;
 - 4. individual accountability;
 - 5. internal audit and investigation; and
 - 6. use of performance plans and personnel evaluations.
